- 1. Technical and commercial terms has not been change to block the participation of all leading CT scan System supplier/ manufacturer.
- 2. Two vendor participated ERBIS and SANRAD in this tender. SANRAD has submitted the bid to complete the Coram and cartelizing this tender. Erbis is distributor of Cannon medical and Sanrad is supplier of Cannon preowned CT system in India market. Technically only one vendor participated in tender and second bid was supporting bid for other.

We request your intervention on the same and looking forward a fare tender practice in the purchase.

I hope you will look in to the matter seriously and justice before spending public money for patient welfare. Please be inform that various CT Scan are also available in GEM portal.
