Assignment Title: Proof Checking Consultancy (Road Protection Works)

The *Government of India intends to receive* financing from the World Bank toward the cost of the Uttarakhand Disaster Recovery Project (UDRP)- Additional Funding, and intends to apply part of the proceeds for consulting services.

The consulting services (“the Services”) shall broadly include proof checking consultancy service of Design and Detailed Project Reports (DPRs) for the construction of road protection works related to World Bank projects initially for four to six months period and will be extendable based on the performance & requirement. The scope of works includes

Proof Checking of DPRs and drawings for nearly 48 numbers of road protection work proposed under additional financing.

The firm will be collecting all the technical, social and environmental and other related information required with the help of other project team members and or consultant in the respective field.

The *PIU(Roads and Bridges), Uttarakhand Disaster Recovery Project, Dehradun, Uttarakhand* now invites eligible consulting firms (hereinafter called “Consultants”) to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The short listing criteria are:

1. The firm should have experiences of completing detailed design/ proof checking of at least 05 number road protection works (treatment of chronic landslides & stability analysis of slopes) as design/ proof checking consultant in assignments related to civil engineering projects.
2. The firm should demonstrate that they have enough capacity (including personnel) in handling detailed design/ proof checking assignment of at least 48 nos. of road protection works in terms of manpower, software and other resources;
3. The firms should be in existence for at least 10 years and have an average annual turnover of at least INR 1.5 crores in the last 3 financial years;

The above mentioned qualification criteria is the minimum criteria and the marking on the criteria will be based on the credentials of the firm.

Expressions of interest (EOI) must include:

- Introductory letter on letter head (with complete contact details – name of contact person, mailing address, telephone, fax, email etc.) explaining how the firm is best to deliver the task
- Organization profile
- Last Three years annual financial statement(including Balance Sheets)
- Certificate regarding annual turnover(converted into INR) for last three years certified by Chartered Accountant
- Short notes on the similar projects implemented by the firm pertaining to the short listing criteria
- Details of similar projects in tabular form including name of project, type and span of bridge, consultancy cost and duration of consultancy services with experience certificates issued by the employer
- The EOI should contain sufficient supporting document to substantiate the claim of the Consultant towards their qualification as per the short listing criteria.

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank's *Guidelines: Selection and Employment of Consultants [under IBRD Loans and IDA Credits & Grants]* by World Bank Borrowers, January 2011 ("Consultant Guidelines"), setting forth the World Bank's policy on conflict of interest.

A Consultant will be selected in accordance with the Quality and Cost Based Selection (QCBS) method set out in the Consultant Guidelines.
